Financial Report:

Current assets as of June 30th, 2022 are \$333,489.83, Expense for June, 2022 were \$29,521.79. Income for June was \$3,228.39. Raritan CD#1 has a balance of \$56,229.80, Raritan CD #2 \$51,704.47, Stronghurst CD#1 \$53,351.99, and Stronghurst CD#2 \$53,627.07.

Prop A: Pullen moved to approve the Financial Report with a second from Fisher. Roll was called and motion carried.

Mileage Rate: IRS increases mileage rate for remainder of 2022. July-December 2022 will raise to \$.625.

Henderson County Health Department:

5-24-22 Director Smith and Baker met with Sharon Graham to discuss the COVID-19 Response Grant – 2022 the health department included the library to hold programs for school children. They received \$11,714.06 to be expended by December 20, 2022, for programs and other services from the Henderson County Public Library.

6-22-22 – Library staff Baker and Tee met with West Central Middle School principal Sara Ryner, staff members Cory, Miller, and Lox to discuss plans for an Escape Room to be held at West Central Middle School.

6-9-22 – Outdoor Family Night included a scavenger hunt, Rhonda Brady presented a program on Monarch butterflies with butterfly crafts. 60 were in attendance for the festivities which also included roasting hot dogs and s'mores.

6-16-22 – 75 stepping stones were made.

6-21-22 – Anna Sharp, the Illinois Ag in the Classroom teacher held a presentation on worms during the storytime hour.

6-23-22 - 203 t-shirts were tie-dyed.

6-24-22 – 146 are currently registered for the summer reading program, 65 have met their first level reading goals, and 50,259 pages have been read.
